Implementation Directions for Social Practice Scholarship

- Article 1. Purpose: The Implementation Directions are formulated in view of encouraging students to care for the society, develop an altruistic spirit, cultivate their social participation and critical thinking skills, and make contributions to the University and the society.
- Article 2. Target recipients: Students of the University (excluding students on leave of absence) who have demonstrated the following achievements during their studies may be recommended as candidates by various units of the University.
- (1) Community care: Participation in social service activities and giving full play to the spirit of mutual assistance.
 - (2) International volunteering: Engaging in international service activities and promoting international exchange.
 - (3) Long-term care: Taking care of the physical and mental health of senior citizens and facilitating education for the elderly.
 - (4) Industrial collaboration: Elevating industrial and cultural development and creating local value.
 - (5) Sustainable environment: Promoting local revitalization and ecological conservation, and improving the quality of life of the people.
 - (6) Food safety: Dedicated to the education on food hygiene and safety to improve the physical and mental health of the people.
 - (7) Students who have other achievements equivalent to the above.
- Article 3. Recommendation: Candidates (individuals or groups) shall be recommended by various units of the University and the Students' Union. If the applicant is applying as a group, they should be recommended in the name of the group.
- Article 4. Application period: Applications shall be submitted to the Social Practice Center (Office of Student Affairs) according to the announced application window in the first semester of each academic year.
- Article 5. Application documents:
- (1) Application form.
 - (2) Specific achievement in social practice.
- Article 6. Quota and commendations:
- (1) In principle, this scholarship is awarded to a maximum of three recipients, including individuals or groups, and may be fewer if there are not enough qualified candidates.
 - (2) Individuals will each be awarded with a scholarship of NT\$50,000 and groups will each be awarded with a scholarship of NT\$100,000.
 - (3) Awarded individuals and groups will be presented with a certificate of merit, and the recipients will be recognized with a major merit and commended at an important assembly.
- Article 7. Reviewing Organization and Method:
- (1) A review committee shall be formed, with the Vice President serving as the convener,

consisting of 2 administrative supervisors nominated by the Office of Student Affairs, 2 teacher representatives, 2 external experts, and 2 student representatives nominated by the student union.

(2) The review process consists of two stages: initial review and secondary review.

①Initial Review: Conducted through document examination, focusing on criteria such as social contributions, resource utilization, richness of information, and creativity.

②Secondary Review: Conducted through interviews, focusing on specific contributions and social impact as review criteria.

Article 8. This scholarship is funded by the student public funds and incentive funds of the University.

Article 9. These Implementation Directions and any amendments thereto become effective after approval by the President after being reviewed by the Student Affairs Committee
